- Unique Multi-model viewing for easy comparison of models and results.
- With one license, there should be unlimited number of users for the creation of models and viewing of data and results
- Data integrity: If results are shown, the model cannot be changed. If the model is changed, results are removed
- Unique, unlimited undo redo function for easier modelling in practice
- Intuitive Windows user interface including copy (Ctrl-C), paste (Ctrl-V), select all (Ctrl-A), undo (Ctrl Z)
- Direct import of measured data from sound level meters

ArcGis:

With ArcGIS the software should import data from ArcGIS and use it for noise calculations. The results can be transferred back to ArcGIS for presentation, processing and archiving.

All data should be kept and managed in ArcGIS, in one place, so no need to transfer data back and fro, or to track data management both in ArcGIS and in Noise Mapping Software. Noise calculations directly from ArcGIS.
