Lab Chairs (Revolving):

Supply of revolving Ohair with backrest made up of 12mm thick (7 layers) hot pressed plywood and moulded back foam upholstered with fabric. Back rest size 480mm (H) x 475mm (W). The seat is made up of 12mm thick (7 layer) hot pressed plywood and moulded seat foam upholster with fabric /leatherette. Seat size 470mmx (W) x480mm (D) the arm rest made up of injection moulded from block polypropylene: Arm rest Size 290mm (L) x60mm (W).
