Preamble:

The Chairman welcomed all the members to the 28th Senate meeting.

A. ITEMS PLACED BEFORE THE 28TH SENATE MEETING HELD ON AUGUST 16TH, 2011.

Nomination of N.I.T.K. Faculty from Senate to the BOG to be reconstituted as per NIT Act 2007.

Resolution of the Senate

The matter was discussed in the light of the resolution, of the 23rd Senate meeting under item no: 23-Senate-C4 wherein it was resolved as follows: "After deliberations the Senate resolved to approve the continuation of the existing procedure of nominating the senior most Professor and Associate/Asst. Professor as a member of the BOG. The term of the office shall be for two years starting from 1st January and ending on 31st December of the subsequent year. The Senate further recommended that in case of two faculty having same seniority then the decision will be based on the seniority at the lower post held by the faculty. The matter to be reported to BOG."

During discussions it was clearly brought out that the subject being discussed is not of an administrative nature, but only to decide the senate representatives on the Board of Governors which is to be reconstituted for the first time in accordance with NIT Act 2007

It was also agreed that the decisions taken in this respect in the Senate would not have any reference to merit of faculty members in the Institute for any other purposes. The inter-se merit between faculty who have been promoted through CAS and faculty recruited through direct open selection is not being addressed in this context. In view of the situation wherein both the categories of nominees for the cadre of Professor and Associate Professor are having the same seniority (i.e. joining date / reporting date being the same in the current position) the matter was discussed.
