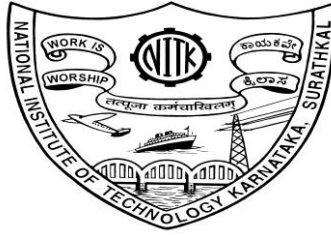

### **DETAILED TECHNICAL SPECIFICATIONS**

Twenty-nine classroom wooden platform stages exist at the Mechanical Engineering Department, NITK Surathkal, and they are to be repaired and varnished. Following is the scope of work

1. Detailed visual and physical surveying of the existing wooden platform for flatness, stability and sound while walking. Dismantling, grinding and reassembling are to be carried out to bring it to a uniform level.
2. Fixing marine plywood of thickness 10 mm on top, front and sides of the wooden platform of the following size and number. The entire platform should be supported with the necessary supports beneath. There should not be any gap at the joints between stages.

Sl.No	Size (Feet)	No of Platform
1	5.5 feet (length) x 5 feet (width) x 1 feet (height)	21
2	5 feet (length) x 5 feet (width) x 1 feet (height)	8

3. The top, front and side portions of the platform should be painted with a single coat of wooden primer followed by two coats of synthetic enamel paint (teak wood finish). The bottom portion of the platform should be painted with a single coat of wooden primer followed by two coats of synthetic enamel paint (white colour).
