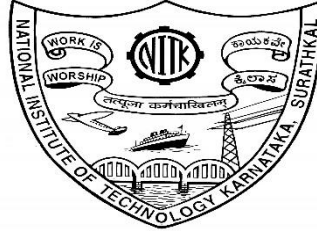

1	60mm thick factory-made cement concrete paver block of rectangular shape and colour of M30 grade made of C&D waste block making machine with the vibratory compaction laid in required pattern and including over 50mm thick compacted bed of coarse sand or 6mm down jelly, filling the joint with fine sand etc.
2	Brickwork with common burnt clay modular bricks of class designation 7.5 in foundation and plinth in Cement mortar 1:4 (1 cement: 4 coarse sand)
