- 1. The age limit for the candidate is 60 years.
- 2. Consolidated Pay:
  - a) For those with Ph.D.: ₹70,000/- per month.
  - b) For those with a Master's Degree (M.E./ M.Tech. or equivalent): ₹55,000/- per month.
- 3. The remuneration shall not be enhanced for any reason during the term of appointment.
- 4. No other allowances are admissible.
- 5. Nature of appointment: The appointment is purely temporary for one semester.
- 6. The interested candidates have to attend walk-in-interview along with a filled-up application form and self-attested necessary documents (Original and self-attested copy).
- 7. Reservation will be as per the Government of India norms.
- 8. If applicable, the candidates are required to enclose their valid Community Certificate in the prescribed format.
- 9. The selected candidates will be required to join immediately.
- 10. Canvassing in any form will render a candidate ineligible.
- 11. The Institute reserves the right to cancel the recruitment process of Temporary Faculty in partial or full without assigning any reasons whatsoever.
- 12. These posts do not confer any right on the applicant to claim either continuous employment or permanency in future.
- 13. No interim correspondence shall be entertained.
