Subject: Decision on appeal preferred by National Institute of Technology Karnataka, Surathkal, Mangluru-575025, Karnataka requesting for grant of accreditation to their PG-Power and Energy Systems program for a period of 6 years instead of the 3 years granted by NBA.

Sir,

This has reference to Appeal dated 21-05-2024 preferred by **National Institute of Technology Karnataka, Surathkal, Mangluru-575025, Karnataka** for granting accreditation to the **PG-Power and Energy Systems** program applied by your Institution for a period of 6 years instead of for a period of 3 years as granted vide NBA's letter of even number dated 01-04-2024.

2. The Appeal has been considered in NBA. The representatives of the Institution also presented the case before the Appellate Committee of NBA in its meeting held on 23-01-2025. The recommendation of the Appellate Committee has been considered by the Competent Authority in NBA. Based on the decision taken, accreditation status of the **PG-Power and Energy Systems** program, in supersession of NBA's letter of even number dated 01/04/2024, is given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **National Institute of Technology Karnataka, Surathkal, Mangluru-575025, Karnataka** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

5. The accreditation status of the above program is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited program as indicated in the table in paragraph 2, appears on the website and information bulletin of the Institute.
